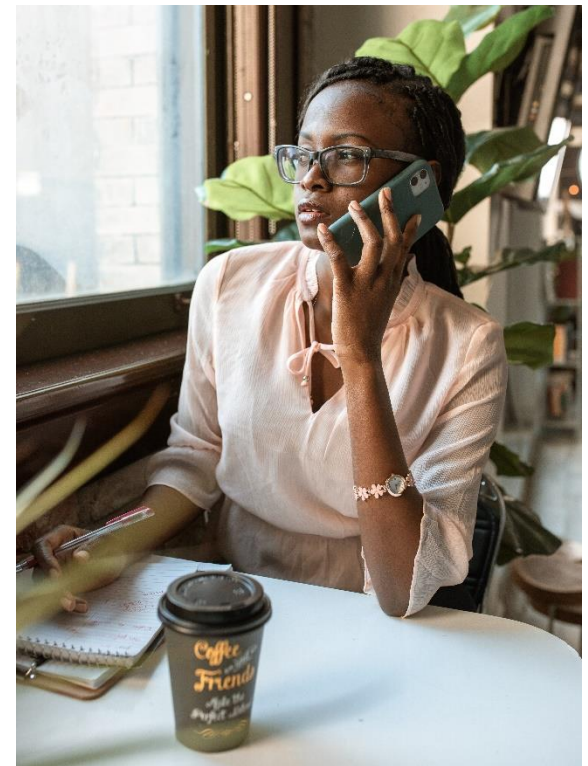

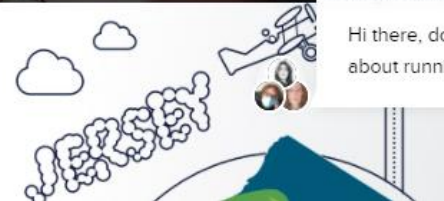

Choosing a Business Entity - Considerations

- Legal liability
- Tax Implications
- Cost of Information and Ongoing Administration
- Flexibility of Ownership Structure
- Suitability to Meet Future Needs

Starting a Business In New Jersey

Sole Proprietorship

- Advantages
 - Easiest to Start & Operate
 - Complete Control
 - No Double Taxation – Easy Tax Preparation
- Disadvantages
 - Unlimited Personal Liability
 - No Partners – Limited to One Person
 - Difficult to Raise Money

Starting a Business In New Jersey

General & Limited Partnerships

- Advantages
 - Simple – Easy to Form & Operate
 - Shared Financial Commitment
 - Favorable Tax Treatment – Profits & Losses flow thru partners
- Disadvantages
 - Joint & Individual Liability
 - Disagreements Among Partners
 - Shared Profits

Starting a Business In New Jersey

Limited Liability Company

- Advantages
 - Limited Liability
 - Less Recordkeeping than Corporation
 - Flexibility of Profit Sharing
- Disadvantages
 - Limited Life
 - Self-Employment Taxes

Starting a Business In New Jersey

Corporation

- Advantages
 - Limited Liability
 - Ability to Generate Capital
 - Corporate Tax Treatment
- Disadvantages
 - Time & Money
 - Double Taxing
 - Additional Paperwork

Starting a Business In New Jersey

S Corporation

- Advantages
 - Tax Savings – No Double Taxation
 - Business Expense Tax Credits
- Disadvantages
 - Strict Operational Processes
 - Shareholder Compensation Requirements

Non-Profit Corporations

The IRS views a non-profit corporation as a company that runs its business for the good of the public.

Nonprofit corporations operate for purposes that are religious, artistic, literary, charitable, scientific, educational & in the interest of public safety

- Charitable Organizations
- Social Welfare Organizations
- Agricultural/Horticultural Organizations
- Labor Organizations
- Business Leagues/Trade Associations

Starting a Business In New Jersey

Non-Profit Corporations

501 (c)(3) Charitable Organization purposes:

- Charitable
- Religious
- Educational
- Scientific
- Literary
- Testing for public safety
- Fostering national/international amateur sports competition
- Prevention of cruelty to children or animals

Starting a Business In New Jersey

Form Your Non-Profit Step-by-Step

- Elect a Board of Directors and Elect Officers
- Obtain an EIN from IRS – Form SS4
- Prepare Articles of Incorporation
- Adopt Bylaws for Your Non-profit
- Obtain Tax Exemption Status from IRS
- File For State Tax Exemption
- File Charity Solicitation Registration
